The preparation and adoption of the Plan is regulated under the Town and Country Planning Act 1990 as amended by the Localism Act 2011. The Plan is prepared by the Stainton and Thornton Neighbourhood Plan group in conjunction with the Stainton and Thornton Parish Council(as the relevant body) and will be "made" by the Council of the LPA. The preparation of Neighbourhood Plans is subject to the following regulations: The Neighbourhood Planning(General)(Amendment) Regulations 2012 and the Neighbourhood Planning (Referendums) Regulations 2012.

2. Is the NP required by legislative, regulatory or administrative provisions? (Art2(a))

Whilst the plan is not a requirement and is optional under the provisions of the Town and Country Planning Act as amended by the Localism Act(2011), it will, if "made" form part of the Development Plan of the LPA. It is therefore important and necessary to answer the following questions to determine whether the policies of the Plan are likely to have significant environmental effects and if further environmental assessments will be required under the EU Directive.

3. As of January 2020, there are internationally designated nature conservation (SPA or SAC) sites near to Stainton and Thornton, the Teesmouth and Cleveland Coast SPA/Ramsar site now extends into Middlesbrough. A separate HRA screening opinion has been undertaken and submitted to Natural England.

YES

- The NP includes some Local Green Spaces within the designated plan area which supports the provision of environmental protection. Some sites within the boundary of the Plan area have been given planning permission for housing and development, in line with the adopted Housing Local Plan for the council.
