Order of Proceedings on the admission of

to the Honorary Freedom of the Borough

on Tuesday 6th February 1996 at Seven O'Clock in the evening.

- The Members of the Council and the Guests will be seated in the Town Hall, Middlesbrough prior to 7.00 p.m.
- The Worshipful the Mayor (Councillor Kenn. J. Hall) preceded by the Mace will take his seat.
- The Mayor will call upon the Director of Legal and Administrative Services to read the Notice convening the special meeting of the Council.
- The Mayor will call upon Councillor K. Walker to propose and Councillor E. Grace to second a Resolution to admit Mr. John Robert Foster O.B.E. to the Honorary Freedom of the Borough.
- After the resolution has been proposed and seconded it may be spoken to by other Members of the Council.
- 6. The Mayor will put the Resolution to the Meeting, and after the same has been declared carried, the Director of Legal and Administrative Services will read the Oath of the Freedom as follows:
  - "Will you John Robert Foster, swear to be true to our Sovereign Lady Queen Elizabeth II, Her Heirs and Successors, as a free and franchised person of this Borough?

Will you preserve the peace and tranquillity of the said Borough, and will you disclose to the Mayor for the time being details of any unlawful meetings or assemblies which come to your attention?

Will you do all in your power to contribute to the good government and safety of the said Borough and the inhabitants thereof?

Will you also defend the customs and privileges of this Borough in every just and lawful cause?

#### SO HELP YOU GOD."

- 7. John Robert Foster O.B.E. will signify acceptance of the Oath by replying, I WILL. The Mayor will then invite him to sign a copy of the Oath and the Roll of Admissions of Freedom. The Signature will be witnessed by the Mayor and the Director of Legal and Administrative Services.
- After the signing of the Roll, the Mayor will present a sealed and illuminated copy of the resolution inscribed on vellum, together with a casket, and will offer congratulations on behalf of the Corporation and People of the Borough.
- 9. The Mayoress will present a bouquet to Mrs. Foster.
- 10. John Robert Foster O.B.E. will reply.
- 11. The Director of Legal and Administrative Services will report the receipt of any communications.
- 12. At the conclusion of the formal proceedings, the Mayor will leave the Town Hall.
- 13. An Invitation is extended to the Members of the Council and Guests to then adjourn to the Crypt for Supper.
