

**THE COUNCIL OF THE BOROUGH OF MIDDLESBROUGH
(A172 DIXONS BANK/STANTON WAY HIGHWAY IMPROVEMENT SCHEME)
(TEMPORARY TRAFFIC REGULATION ORDER) 2019**

NOTICE is hereby given that Middlesbrough Council intends to make an Order to prevent vehicles from using the lengths of road set out below whilst highway improvement works are carried out because of the likelihood of danger to the travelling public and site operatives.

The roads affected are as follows:

1. Full Road Closures

Road	Extent of Closure
Stainton Way	From its junction with The Fairway to its junction with A172 Dixons Bank, a distance of approximately 380 metres.
	From its junction with A172 Dixons Bank to its junction with Shevington Grove, a distance of approximately 130 metres.

2. Closure in One Direction Only

Road	Extent of Closure
A172 Dixons Bank (only northbound traffic movements permitted)	From its junction with Stainton Way to its junction with Brass Castle Lane, a distance of approximately 760 metres.

3. 20 mph Speed Restriction

Road	Extent of Closure
A172 Dixons Bank	From a point 130 metres to the north west of its junction with Stainton Way to its junction with Brass Castle Lane, a distance of approximately 910 metres.
Stainton Way	From its junction with The Fairway to its junction with Shevington Grove, a distance of approximately 520 metres.

Access for pedestrians and emergency services' vehicles will be maintained at all times.

The Order will come into force on Monday 19th August 2019, and will remain in force until the works have been completed and there is no longer a danger to the public. The works are programmed for completion during the week commencing Monday 23rd September 2019, although this date is subject to change due to unforeseen circumstances.

The primary signposted diversion routes whilst the closures of Stainton Way are in operation will be as follows:

- Eastbound traffic will be diverted via Stainton Way, B1365 Hemlington Lane, A1032 Ladgate Lane, A174 Parkway, A172 Stokesley Road and A172 Dixons Bank.
- Westbound traffic will be diverted via Mallowdale, Clevegate, Guisborough Road and A172 Dixons Bank.

The primary signposted diversion route whilst the closure of A172 Dixons Bank (southbound) is in operation will be via A172 Dixons Bank, A172 Stokesley Road, B1380 Ladgate Lane, B1380 Ormesby High Street, A171 Sunnyfield, A171 Orchard Way, A171 Ormesby Bank, A1043 Nunthorpe Bypass and A172 Dixons Bank.

Secondary diversion routes will be signed as necessary whilst the closures are in operation.

If the works are not completed within 18 months, the Order may be extended with the approval of the Secretary of State.
